The Government body of the City of Rio Hondo, Texas met in a Special Meeting on April 14, 2020 at 6:30 pm in the Commission Chambers at City Hall, with Mayor Gustavo Olivares presiding and Mayor Pro-tem Gerald Hartzog, Commissioners Rick Tello, and Margaret Perez in attendance. Commissioner Joseph Lopez and Alonzo Garza were absent.

Others present: Ben Medina, City Administrator; Sylvia Garcia, City Secretary; and Lucia Garza, Finance/Human Services Director.

REGULAR AGENDA:

On April 23, Governor Abbott announced that Texas A&M AgriLife Extension Service will provide a series of free online trainings to help local officials understand, acquire, and administer federal assistance available to the state of Texas and municipalities through the Stafford Disaster Relief and Emergency Assistance Act and recently passed Coronavirus Aid, Relief, and Economic Security (CARES) Act. Beginning today, AgriLife Extension will offer these trainings online to help local leaders navigate the federal funding process, and in turn, respond and recover from the COVID-19 pandemic as quickly and effectively as possible.

In conjunction with the announcement, the Governor joined Texas A&M University System Chancellor John Sharp and Texas Division of Emergency Management Chief Nim Kidd for a series of calls with Mayors and County Judges, members of the Texas Legislature, and the Texas

congressional delegation today to provide details on the training, walk leaders through the process, and answer questions about federal funding.

"Our local officials have done a tremendous job leading their communities throughout the COVID-19 response, and the state of Texas will continue to work alongside them and provide these leaders with the resources and support they need during this challenging time," said Governor Abbott. "These online trainings will assist local leaders in efficiently navigating the federal funding process and ensure that our communities receive the financial support that they need in a timely manner."

"One thing we learned during our response to Hurricane Harvey was that federal funding is invaluable in the recovery process," said John Sharp, Chancellor of The Texas A&M University System. "However, it comes with all sorts of strings and requirements that can be confusing to those who don't know the rules. AgriLife Extension agents are well-positioned to guide county judges, mayors and other local officials through the federal funding maze."

The first online training, <u>Federal Relief: An overview for local governments</u>, is available now. Additional trainings will dive into the specifics of individual programs based on the needs of state and local officials. Extension agents will be available to assist local leaders with questions throughout the training and subsequent federal funding application process.

The CARES Act authorizes approximately \$2 trillion in federal stimulus funds to combat the crisis and stabilize the economy, including \$150 billion available directly to states, territories and tribal governments. This includes a number of programs to address the issues that states and local governments are facing as they work to protect their communities during this challenging time.

The Texas A&M AgriLife Extension Service is a unique education agency that provides programs, tools, and resources on a local and statewide level that teach people improved agriculture and food production, advanced health practices, environmental protection, economic, and youth programs.

On April 23, Governor Abbott announced that Texas Health and Human Services Commission (HHSC) will receive nearly \$54 million in federal funds to support older Texans and people with disabilities during the COVID-19 response. The funding will be used to support programs and services administered by the state's 28 Area Agencies on Aging such as home delivered meals, help with household chores, assistance with groceries, and respite care or other services for family caregivers.

"Older Texans and Texans with disabilities face a higher risk of severe illness from COVID-19, and they need continued support during these trying times," said Governor Abbott. "These federal funds will help provide higher risk Texans with additional support and resources to meet their everyday needs while allowing them to stay at home and stay safe. I thank the U.S. Department of Health and Human Services for providing Texas with this crucial financial support so that we can continue to serve our fellow Texans."

"With Governor Abbott's continued leadership, we're committed to supporting and assisting the state's most vulnerable population during the difficult time," said HHS Executive Commissioner Phil Wilson.

Funding will also be used to support the Long-Term Care Ombudsman, which provides advocacy and complaint resolution services on behalf of residents in long-term care facilities.

The U.S. Department of Health and Human Services' Administration for Community Living awarded Texas nearly \$54 million in funds through the federal Coronavirus Aid, Relief, and Economic (CARES) Act recently signed into law by President Trump.

On April 22, Governor Abbott temporarily waived certain restrictions to allow Texas higher education institutions to transfer all unexpended student financial aid funds from the Texas College Work-Study (TCWS) program to other financial aid programs that do not have a work-study requirement to ensure students will continue receiving financial assistance. Those programs include the TEXAS Grant program, the Texas Educational Opportunity Grant program, and the Tuition Equalization Grant program.

With physical campuses closed or under limited operation, this waiver will help students who normally rely on the TCWS program to receive other forms of financial assistance they may need to continue their education.

On April 22, Governor Abbott waived certain testing requirements for Advance Practice Registered Nurses (APRN) as part of the state's response to COVID-19. As a result of this waiver, new APRN graduates who have applied for APRN licensure with the Board of Nursing and have met all licensure requirements except national certification may begin practicing under direct physician supervision. This graduate approval does not include prescriptive authority.

On April 22, Texas Attorney General Ken Paxton applauded the United States Court of Appeals for the Fifth Circuit for ordering a stay that blocks a lower court order sharply limiting state officials' ability to respond to the rapidly developing COVID-19 pandemic in Texas prisons and across the State. The district court's injunction imposed limits on the transfer of inmates, required unrestricted access to face masks, hand sanitizer and cleaning supplies for each inmate, and imposed a plan for testing every single inmate for COVID-19. The Fifth Circuit also expedited arguments in this case.

On April 21, Governor Abbott provided an update on job openings in the Lone Star State and outlined resources for Texans seeking employment due to the economic effects of COVID-19. The Governor also announced that nearly 500,000 job openings are currently listed on WorkInTexas.com, a powerful online job matching and workforce solution system developed by the Texas Workforce Commission (TWC). This system provides fast access to a complete set of employment tools in one website where job seekers can browse job postings, find education and training, and complete resumes and state applications.

Job seekers can visit Texas Economic Development and Tourism's Texas Jobs page for links to all 28 local workforce development boards. The webpage also contains additional COVID-19 resources for employers and job seekers alike.

On April 20, Governor Abbott announced that the Texas National Guard will be mobilizing more than 1,200 personnel as part of COVID-19 mobile testing teams (MTT). The 45 member teams will be mobilized in various parts of the state providing greater access to medical testing.

The teams will have 11 medical professionals and support staff, as well as 34 soldiers. Currently,

the Texas National Guard has the capacity to test 150 people per day at each mobile testing team location.

The Texas Military Department was activated by Governor Abbott in March to assist communities across Texas in the COVID-19 response. Currently, over 2,900 Guardsmen are serving in various capacities in response to this activation.

In accordance with guidance from DSHS Commissioner Dr. Hellerstedt, and to achieve the goals established by the President to reduce the spread of COVID-19, every person in Texas shall, except where necessary to provide or obtain essential services or reopened services, minimize social gatherings and minimize in-person contact with people who are not in the same household.

"Essential services" shall consist of everything listed by the U.S. Department of Homeland Security (DHS) in its Guidance on the Essential Critical Infrastructure Workforce, Version 2.0 or any subsequent version, plus religious services conducted in churches, congregations, and houses of worship.

Other essential services may be added to this list with the approval of the Texas Division of Emergency Management (TDEM). TDEM shall maintain an online list of essential services, as specified in this executive order and any approved additions. Requests for additions should be directed to TDEM at EssentialServices@tdem.texas.gov or by visiting www.tdem.texas.gov/essentialservices.

On April 17, Governor Abbott held a press conference where he issued three new Executive Orders (EO-GA-15, EO-GA-16, and EO-GA-17) to begin the process of reopening the State of Texas while revising hospital capacity and certain social distancing guidelines.

On April 13, Texas Attorney General Ken Paxton filed a motion to intervene into a federal lawsuit seeking to stop the release of inmates from the Dallas County Jail, including killers, rapists, arsonists and armed robbers. The Texas Supreme Court stopped an unlawful decision by a state district court in Travis County which would have blocked Governor Abbott's Executive Order GA 13 and allowed the release of inmates en masse.

On April 12, Governor Abbott issued a proclamation extending his Disaster Declaration for all Texas counties in response to COVID-19. Originally issued on March 13th, the Disaster Declaration provides the state a number of resources to effectively serve Texans as the Lone Star State continues to mitigate the spread of COVID-19.

On April 11, Governor Abbott waived certain regulations related to restrictions on physicians-in-training (PIT) permit holders in order to increase health care capacity through the state's response to COVID-19.

On April 10, Governor Abbott held a press conference where he provided an update on the state's response to COVID-19. The Governor discussed numbers related to COVID-19 cases, hospitalizations, and fatalities in Texas counties.

In addition, the Governor announced a new online <u>Frontline Child Care Website</u> to help essential workers in Texas locate child care and support child care centers who are caring for children during the outbreak. <u>https://frontlinechildcare.texas.gov</u>

On April 9, Governor Abbott temporarily waived a series of regulations to lift certain telehealth restrictions and expand telehealth options as Texas responds to COVID-19.

On April 9, Governor Abbott announced that the HHSC has adopted an emergency rule to temporarily allow more nurse aides to serve residents in long-term care facilities during the COVID-19 response.

On April 8, Governor Abbott suspended certain statutes concerning appearance before a notary public to execute a self-proved will, a durable power of attorney, a medical power of attorney, a directive to physician, or an oath of an executor, administrator, or guardian. These suspensions temporarily allow for appearance before a notary public via videoconference when executing such documents, avoiding the need for in-person contact during the COVID-19 pandemic.

On April 8, Governor Abbott announced that his Public Safety Office (PSO) will provide a one-time emergency waiver of the federally required cash or in-kind match contribution required for the Victims of Crime Act (VOCA) and STOP Violence Against Women Act (VAWA) grant funds.

On April 8, Governor Abbott announced that Texas Health and Human Services (HHS) will provide more than \$168 million in emergency Supplemental Nutrition Assistance Program (SNAP) food benefits to help Texans during the COVID-19 response. More information about SNAP benefits.

On April 8, Governor Abbott held a press conference where he provided an update on the production and distribution of personal protective equipment (PPE) in Texas. The Governor announced a new partnership between the Texas Military Department (TMD) and Prestige Ameritech to increase the production of face masks for health care workers.

On April 7, Governor Abbott temporarily waived certain regulatory requirements to increase the job capacities of pharmacy technicians and pharmacy interns.

On April 7, Governor Abbott announced that the Texas Health and Human Services Commission (HHSC) has adopted an emergency rule to allow end stage renal disease (ESRD) facilities to treat patients more effectively during the COVID-19 response.

On April 7, Governor Abbott directed the Texas Parks and Wildlife Department (TPWD) and the Texas Historical Commission (THC) to close all state parks and historic sites as part of the state's efforts to strengthen social distancing practices and prevent gatherings of large groups of people.

On April 7, the Fifth Circuit of the United States Court of Appeals upheld Governor Abbott's Executive Order GA 09, which requires all health care facilities and professionals to postpone any unnecessary medical procedures to free up hospital beds and preserve precious medical supplies for those combating the spread of COVID-19.

On April 6, Governor Abbott held a press conference to provide an update on personal protective equipment (PPE) distribution throughout the state of Texas.

Governor Abbott announced that Care.com is increasing in-home child care access for frontline workers responding to the COVID-19 emergency.

On April 6, Texas Health and Human Services announces Texas WIC, the special supplemental nutrition program for women, infants, and children, is expanding the number of food items eligible for purchase through the program. WIC participants can find detailed information on the <u>Texas WIC website</u>.

On April 5, Governor Abbott temporarily waived certain regulations to expand the health care workforce to assist with Texas' COVID-19 response.

On April 3, Governor Abbott held a press conference to provide an update on Texas hospital capacity. During the press conference, the Governor and Dr. Zerwas presented an overview of statewide hospital bed capacity, as well as a detailed analysis of bed availability by region. Texas has increased by over 140% since March 18th.

On April 2, Governor Abbott suspended regulations to increase the amount of Emergency Medical Services (EMS) workers and first responders in Texas during the state's response to COVID-19.

On April 1, Governor Abbott issued a statement regarding the recently passed \$2 trillion federal stimulus package intended to relieve the economic impact of the COVID-19 pandemic, with a special focus on unemployed workers and the state's hardest-hit businesses.

On April 1, Governor Abbott and the Texas Department of Housing and Community Affairs (TDHCA) took initial action to provide tenant-based rental assistance for Texans experiencing financial hardship due to COVID-19.

On March 31, Governor Abbott issued an Executive Order implementing Essential Services and Activities Protocols for the entire state of Texas. The protocols direct all Texans to minimize non-essential gatherings and in-person contact with people who are not in the same household. The Governor's Executive Order renews and amends his previous order enforcing federal social distancing guidelines for COVID-19, including closing schools and instructing Texans to avoid eating or drinking at bars and restaurants. The protocols allow exceptions for essential activities and services based on the Department of Homeland Security's guidelines on the Essential Critical Infrastructure Workforce.

Governor Abbott and Attorney General Paxton issued joint guidance regarding the effect of Executive Order GA 14 on religious services conducted in congregations and houses of worship.

These orders will be effective on a statewide basis starting at 12:01 AM on April 2, 2020 and will end on April 30, 2020, subject to extension thereafter based on the status of COVID-19 in Texas and the recommendations of the CDC. View the Governor's Executive Order.

On March 31, Governor Abbott announced the Comfort Food Care Package (CFCP) program to provide meals for at-risk youth and families in communities across Texas as the state responds to COVID-19. Texas Restaurant Association website.

On March 30, Governor Abbott waived certain statutory provisions to ensure public safety employees who contract COVID-19 during the course of their employment will be reimbursed for reasonable medical expenses related to their treatment of COVID-19.

On March 30, Governor Abbott announced that the <u>Center for Medicaid and Medicare Services</u> (CMS) (<u>www.cms.gov</u>) has approved the Section 1135 Medicaid Waiver submitted by the Texas Health and Human Services Commission (HHSC) on March 26, 2020. This approval grants Texas flexibility in administering Medicaid while the state continues to respond to COVID-19.

On March 29, The Vice President of the United States sent a letter to all Hospital Administrators; At the President's direction, we are requesting that all hospitals report the following information to HHS:

1, COVID-19 Test Result Reporting

- a. We are requesting that all hospitals report data on COVID-19 testing performed in your Academic/University/Hospital in-house laboratories. If all of your COVID-19 testing is sent out to private labs and performed by 011e of the commercial laboratories 011 the list below, you do not need to report using this spreadsheet.
 - i.. Commercial laboratories: LabCorp, BioReference Laboratories. Quest Diagnostics, Mayo Clinic Laboratories, and ARUP Laboratories.
- b. Reporting Instructions: We request that all data for COVID-19 testing completed at "inhouse" laboratories or a laboratory not listed above be reported using the attached spreadsheet.
 - i. Due date/time: The spreadsheet is due EVERY day at 5 PM ET.
 - ii. Data to report: The data elements are outlined in the spreadsheet [emailed separately], but should include all test results that were completed during the previous day with a midnight cutoff.
 - iii. Where to submit: Submit the spreadsheet via email to <u>fema-hhs-coviddiagnostics-tf@fema.dhs.gov</u>.
 - iv. Data elements to report: Included in the attached spreadsheet with definitions.

- 2. National Healthcare Safety Network (NHSN) COVID-19 Module

a. To monitor the rapid emergence of COVID-19 and the impact on the healthcare system, all hospitals should report data each day to the National Healthcare Safety network (NHSN) COVID-19 Patient Impact and Hospital Capacity Module, which has been made available for hospitals to use beginning March 27, 2020. All hospitals that currently use NHS have received an email from the CDC with additional details about how to report to the new module. Although most hospitals already regularly submit data to NHSN on healthcare-associated infections for purposes of CMS reporting, the data we are now asking you to report is necessary in monitoring the spread of severe COVID-19 illness and death as well as the impact to hospitals. Additional details can be found in the attached documents and at the following website: http://www.cdc.gov/nhsn/acute-care-hospital/covid 19/index.html.

On March 29, Governor Abbott issued two executive orders (GA - 12) and (GA - 13).

On March 28, Governor Abbott waived certain regulations allowing for an expedited licensing reactivation process for Advanced Practice Registered Nurses (APRN) in Texas.

On March 28, Governor Abbott waived certain licensing renewal regulations for Texas pharmacists, pharmacy technicians, and pharmacy technician trainees.

On March 27, as part of the state's ongoing response to COVID-19, Governor Abbott announced the deployment of three National Guard Joint Task Force Brigades. The 72nd Infantry Brigade Combat Team, the 56th Infantry Brigade Combat Team, and the 176th Engineer Brigade.

On March 27, Governor Abbott waived certain Texas Workforce Commission (TWC) regulations to preserve and extend child care capacity for front line workers.

On March 26, Governor Abbott announced his request for access to interest-free federal loans (known as Title XII funds) to pay unemployment claims and the accelerated release of funds from the Texas account of the federal Unemployment Trust Fund.

On March 26, Governor Abbott, ordered the following on a statewide basis effective at noon on March 28, 2020:

Every person who enters the State of Texas as the final destination through an airport, from a point of origin or point of last departure in New York, New Jersey, Connecticut, or the City of New Orleans, or in any other state or city as may be proclaimed hereafter, shall be subject to mandatory self-quarantine for a period of 14 days from the time of entry into Texas or the duration of the person's presence in Texas, whichever is shorter. Each person covered under this order to self-quarantine shall be responsible for all associated costs, including transportation, lodging, food, and medical care.

This executive order shall remain in effect and in full force until modified, amended, rescinded, or superseded by the governor.

On March 25, Governor Abbott released a statement thanking President Trump for issuing a Major Disaster Declaration (DR-4485) for the State of Texas.

Governor Abbott has temporarily waived certain hospital licensing rules and the Texas Health and Human Services Commission (HHSC) has adopted an emergency rule to meet Texas' need for additional hospital capacity while the state responds to COVID-19.

Governor Abbott has waived certain regulations from the Texas Board of Nursing regarding licensing renewal and subsequent fees for nurses in Texas.

On March 24, Governor Abbott directed the Texas Department of State Health Services (DSHS) to issue guidance allowing restaurants to sell bulk retail products from restaurant supply chain distributors directly to consumers provided that such foods are in their original condition, packaging, or presented as received by the restaurant.

On March 23, Governor Abbott sent a letter to President Trump requesting a presidential declaration of a major disaster in Texas based on the continued impact of COVID-19.

Governor Abbott's letter also detailed the state's efforts to mitigate the impact of COVID-19, including executing the state's emergency management plan and issuing multiple executive orders, in accordance with guidelines from President Trump and the Centers for Disease Control and Prevention (CDC).

The Governor has also issued multiple waivers of state law to remove barriers limiting the response to this pandemic and activated the Texas National Guard to be prepared to assist with response efforts for COVID-19.

The letter also designated Chief Nim Kidd as the Governor's Authorized Representative and State Coordinating Officer, tasked with continuing his coordination with FEMA on all matters related to COVID-19.

On March 22, the Governor signed an Executive Order for hospitals to increase unused bed capacity without submitting an application or associated fees. The order also creates a Supply Chain Strike Force to ensure all health care facilities have the supplies and resources they need. This executive order takes effect immediately and remains in effect until April 21.

March 20, The U.S. Food & Drug Administration (FDA) released an announcement that warns consumers about unauthorized fraudulent coronavirus tests. Reports may be sent via email to: FDA-COVID-19-Fraudulent-Products@fda.hhs.gov.

On March 19, Governor Abbot issued four Executive Orders to mitigate the spread of COVID-19 in Texas.

Order No. 1 - In accordance with the Guidelines from the President and the CDC, every person in Texas shall avoid social gatherings in groups of more than 10 people.

Order No. 2 - In accordance with the Guidelines from the President and the CDC, people shall avoid eating or drinking at bars, restaurants, and food courts, or visiting gyms or massage parlors; provided, however, that the use of drive-thru, pickup, or delivery options is allowed and highly encouraged throughout the limited duration of this executive order.

Order No. 3 - In accordance with the Guidelines from the President and the CDC, people shall not visit nursing homes or retirement or long-term care facilities unless to provide critical assistance.

Order No. 4 - In accordance with the Guidelines from the President and the CDC, schools shall temporarily close.

This executive order supersedes all previous orders on this matter that are in conflict or inconsistent with its terms, and this order shall remain in effect and in full force until 11:59 PM on April 3, subject to being extended, modified, amended, rescinded, or superseded by me or by a succeeding governor.

Governor Abbott also announced that the U.S. Small Business Administration (SBA) has included the entire state of Texas in its Economic Injury Disaster Declaration and granted access to its Economic Injury Disaster Loan (EIDL) program, which will provide long-term, low interest loans to qualifying businesses across the state.

On March 19, The Commissioner of the Department of State Health Services, Dr. John Hellerstedt, issued a Public Health Disaster Declaration in Texas.

On March 18, Governor Abbott issued a waiver that will allow restaurants to deliver alcoholic beverages with food purchases to patrons, including beer, wine, and mixed drinks.

On March 18, Governor Abbott, announced that Texas Department of Public Safety (DPS) Driver License Offices across the state are closing immediately.

Governor Abbott announced that he has directed the Texas Department of Public Safety (DPS) to temporarily waive expiration dates for Driver Licenses, Commercial Driver Licenses, and other identification forms. This action falls within the Governor's State of Disaster Declaration and is part of the ongoing effort to reduce to spread of COVID-19.

Governor Abbott announced that he is activating the Texas National Guard in response to the novel coronavirus outbreak in the state.

Governor Abbott issued a proclamation suspending provisions of the Texas Election Code to allow political subdivisions to postpone their 2020 local elections.

Governor Abbott has announced that Texas is waiving certain rules relating to parking placards for persons with disabilities.

Governor Abbott and the Texas Education Agency (TEA) announced a collaboration with local education agencies (LEA) on the Texas Students MealFinder Map which will allow Texas parents to locate LEA facilities serving meals in their communities.

Governor Abbott announced that he is temporarily suspending certain regulations to ensure that Texans will have continued access to their pharmacists as the state responds to COVID-19.

The Governor also announced the launch of an online portal run by the Supply Chain Strike Force to streamline the process and validation of leads for more supplies. The portal, accessible through

www.texas.gov, will serve as an intake process for those wanting to provide valid leads on PPE and donations. The Governor also issued an Executive Order to better track both hospital bed capacity and COVID-19 test results across the state. The order also requires every public or private entity utilizing FDA-approved COVID-19 tests to submit daily reports of all results to the local health department and DSHS who will then share this information with the CDC.

On March 17, Governor Abbott waived certain regulations and directed that the Texas Department of Insurance (TDI) issue an emergency rule, relating to telemedicine care for patients with state-regulated insurance plans.

On March 14, Governor Abbott, directed the Texas Medical Board (TMB) and the Texas Board of Nursing (TBN) to fast-track the temporary licensing of out-of-state physicians, physician assistants, certain retired physicians, nurses, and other license types to assist in Texas' response to COVID-19.

The Governor suspended State of Texas Assessments of Academic Readiness (STAR) testing for the state. Governor Abbott has suspended various provisions that require government officials and members of the public to be physically present at a specified meeting location.

On March 13, the President of the United States Donald Trump declared that the COVID-19 global pandemic is a national emergency.

On March 13, the Governor of the State of Texas Abbott issued a proclamation certifying that COVID-19 poses an imminent threat in the state and declared a state of disaster for all 254 counties in Texas.

The Texas Department of Agriculture (TDA) Commissioner Sid Miller announced TDA has been granted flexibility from the federal school meal program to allow Texas schools to continue to provide meals to students even if temporarily closed.

The CDC and Texas Department of State Health Services (DSHS) coronavirus webpages are reliable sources of information. DSHS is monitoring the Texas situation seven days a week.

Tarrant County: Fort Worth Fire Department has opened a COVID-19 testing center available to front line health care workers including physicians, nurses, medical assistants and other health professionals. Call the Infections Disease Coordinator at the Joint Emergency Operations Center (EOC) at the City of Fort Worth at 817-714-9709. This number is answered from \$600 AM to 5:00 PM daily.

Wise County: COVID testing site is utilizing the parking lot of the Bridgeport hospital. Bridgeport tests by appointment only for now and the site will be run by Wise Health Systems. Open daily from 9:00 AM -5:00 PM.

DDC 4 - Garland (Includes: Collin, Dallas, Ellis, Hunt, Kaufman, Navarro and Rockwall Counties)

Dallas County: Dallas County issued an amended Declaration of Local Disaster for Public Health Emergency; beginning 11:59 PM April 16 and expiring 11:59 PM April 30. All persons going to an essential business will be required to wear a covering for nose and mouth.

NCTTRAC updates

The NCTTRAC TSA-E MEDICAL COORDINATION CENTER (EMCC): The EMCC remains at full activation seven days a week. The EMCC continues to receive and disperse shipments of supplies from the Department of State Health Services and Texas Division of Emergency Management, and assists in the coordination of PPE logistics across the region. On April 22, 211 handled 403 calls. The top unmet needs were undesignated temporary financial assistance, food pantries, motel payment assistance, and utility deposits. The top calls were for electric service payment assistance, undesignated temporary financial assistance, rent payment assistance, food stamps/SNAP, and COVID-19 control.

Texas A&M AgriLife Extension Service:

Anderson County: Cayuga ISD has been approved to restart their meal services this week through the meal program (state funding).

Due to CDC recommendation, CHRISTUS System is asking all patients, visitors and employees to wear a mask while visiting their facilities. Homemade cloth masks are appropriate for visitors. Providers and health care workers will continue to use appropriate medical masks (PPE) when working.

Physicians with The University of Texas Health Science Center at Tyler and UT Health East Texas are researching a potential treatment to help severely afflicted COVID-19 patients recover. Individuals with a history of COVID-19 can donate plasma but must first meet FDA requirements for this research and must be tested for safety. Once safe usage is confirmed, the blood then goes through a process to separate out blood cells, leaving the plasma with antibodies. Patients who have successfully recovered from COVID-19 are encouraged to contact Carter BloodCare for donation options.

April 21, 211 handled 182 calls. Acceptable coverings include "some form of face covering that covers the nose and mouth. The face covering may be a homemade mask, scarf, bandana, or handkerchief." The Centers for Disease Control provides guidance on effective face coverings.

This is in addition to social distancing and personal hygiene guidelines already in place. Wearing

a face covering is not a substitute for maintaining 6-feet social distancing and hand washing because these remain important steps to slowing the spread of the virus.

Per the order, face coverings shall be worn except when:

- · Exercising outside or engaging in physical activity outside;
- Alone in a separate single space, whether indoors or outdoors;
- In the presence only of other members of one's residence, whether inside or outside the residence;
- When doing so poses a greater mental or physical health, safety or security risk; or
- · When eating or drinking.

Residents are asked not to use medical masks or N95 respirators as they are important resources for both medical workers and first responders. Harris County will not provide equipment for private employers or the public.

This order is enforceable by all law enforcement agencies in Harris County. Violators face up to a \$1,000 fine.

South East Texas Regional Advisory Council (SETRAC) - Catastrophic Medical Operations Center (CMOC): With the spread of COVID-19 in our nation reaching a point where identification of COVID-19 patients in the greater Houston area has been reached, the CMOC has activated Level 1 and is likely to remain so for the foreseeable future, to support regional healthcare organizations in response to the COVID-19 incident, with the aim of maintaining the regional healthcare infrastructure.

As directed by DSHS, SETRAC will lead the planning and coordination efforts for local CSSCCs

that supplement Texas' hospital capacity enabling hospitals to direct resources toward acute COVID-19 patient and non-COVID-19 patient emergency care.

Texas A&M AgriLife Extension Service (AgriLife): AgriLife activated one Regional Program Leader to assist TDEM DDC 6.

The agency is standing ready with personnel to support TDEM with activations of DDEOC's across the state. Strike Team members, county Extension Agents and vehicles are also on standby and are prepared to assist with rural Mobile Specimen Collection sites. Disaster Strike Team members made three PPE deliveries April 22 for Mobile Specimen Collection Sites in Del Rio, Center and Van Horn.

Slide presentations and videos are being developed for use by county Extension agents to demonstrate handwashing and disinfecting. A resource video entitled "Scrub Up, Tune Up" has been posted for the public to view and Extension agents to utilize as a teaching tool for proper handwashing. These have been translated into Spanish for Spanish speaking clientele. A new power point on cleaning and household disinfecting in household settings has also been posted on the site for educational use by Extension Agents.

As of April 20, 8,316 masks have been distributed to persons at high risk of contracting COVID 19 through the AgriLife Extension statewide Face Mask project. Masks are being made by 4-H youth, Texas Extension Education and Healthy Texas volunteers.

A promotional flyer for Mobile Specimen Collection in counties was developed by Ag. Communications for distribution in rural counties where collections will occur. Copies were sent to TDEM and DSHS today for distribution as well.

Texas A&M Engineering Extension Service (TEEX): TEEX continues to support COVID-19 response across Texas.

Additional LNO for RSOC in place on April 20 to allow for staff rotation/down time and assist with SOC duties.

All 8 armories received shipments for the Mobile Rural Testing Team (MRTT) resupply mission. The San Antonio Armory also received 15 pallets of PPE as the initial PPE issue for the MRTT.

Texas A&M Forest Service (TFS): TFS currently has 66 personnel committed to COVID-19 Response and is providing planning support, logistical support, and other functional areas as needed throughout the state. TFS resources are assisting the Texas Division of Emergency Management, Texas Department of State Health Services, and local jurisdictions. Assistance activities include Incident Action Plan development, Situation Reports, STAR Processing, Personal Protective Equipment hauling, logistical support for shipping and receiving materials, incident management support, and training.

Texas Commission on Environmental Quality (TCEQ): TCEQ has created a link specific for COVID-19 on our public webpage.

Texas Department of Licensing and Regulation (TDLR):

TDLR requested and received authority from Governor Abbott to suspend certain regulatory requirements to allow licensees of the Offender Education Program to provide more services through remote classroom instruction during the pandemic.

Texas Department of Health Services (DSHS):

Regional Activities:

On April 21, Public Health Regions (PHRs) reported 332 personnel working in the RHMOCs. All RHMOCs are at Full Activation.

All eight HPP Providers have activated Regional Operations Centers and are distributing PPE to healthcare entities in the region.

SMOC will receive six Battelle decontamination systems from FEMA that will be able to clean 80,000 N95 masks a day. The first two systems will reach Houston and San Antonio as early as April 22.

DSHS purchased materials for Texas Military Department (TMD) to install racking systems in the FEMA cold storage trailers to increase storage capacity.

DSHS Call Center Activities:

The Call Center received 13,024 calls and 8,029 emails to date. Over the past 24 hours, the Call Center received a total of 84 calls and 108 emails. The Call Center is operational 7:00 AM – 8:00 PM every day of the week.

As of March 14, 2-1-1 has been funneling calls to the DSHS Call Center. 2-1-1 reports receiving a total of 3,865 calls in the last 24 hours. Texas Poison Center Network received 727 COVID-19 calls as of April 22.

Two of the eight Battelle Decontamination Systems have deployed to the regional destinations. Each system has capacity to clean and decontaminate 80,000+ n95 masks a day.

Texas Education Agency (TEA):

Texas Health and Human Services Commission (HHSC): Texas HHSC temporarily suspended non-essential visits to State Hospitals and State Supported Living Centers.

Texas Military Department (TMD): Governor Abbott activated the Texas National Guard on Tuesday, March 17 to help with the state's response to coronavirus. TMD currently has 2,838 personnel in support of the COVID-19 Response. Two TMD General Support Units are operating in support of testing sites in Kingsville and Houston. Eight TMD GSUs are staging in Dallas, San Antonio, Corpus Christi, Lubbock, Austin, Houston, El Paso, Weslaco and Tyler to implement the TDEM distribution plan to the RACs. TMD MDCs are supporting DDCs in 2, 04A, 04B, 6, 7, 8, 12, 13, 14, 16A, 16C, 16D, 18B, 19, DDC 20 and 21 and DDC 24. TMD is supporting the manufacture of n95 masks. TMD is assisting TDEM with warehouse distribution of PPE. TMD is supporting the North Texas Food Bank, the South Texas Food Bank, the Rio Grande

Valley Food Bank, Harris County Food Bank, Tarrant County Food Bank, and the El Paso Food Bank with distribution. TMD is supporting the State Operations Center. TMD Engineering Facility Assessment teams are actively evaluating alternate care medical facilities for COVID 19 patient overflow potential. The TMD Engineering team is working with the Army Corp of Engineers. TMD is supporting Community Based Testing site operations in Houston, Moore County, Victoria, Van Horn, and Terrell City. TMD is supporting TDEM Critical Information Systems with data compilation and STAR repositioning. TDEM is supporting the Department of State Health Services by tracking PPE distribution to health care facilities.

Texas Parks and Wildlife Department (TPWD): TPWD is monitoring the COVID-19 situation closely and making agency adjustments based on the DSHS and CDC guidelines to ensure the health and safety of employees, volunteers, and the public visiting TPWD facilities.

Texas Game Wardens are currently assisting with Rural COVID-19 Testing sites.

On April 17, DDC 4B Garland Command Staff began a one day per week schedule with the TPWD Liaison covering Mondays and Wednesdays.

On April 20, All State Parks reopened for day-use only, as part of a broader effort to begin reopening the state of Texas. Per Governor Abbott's direction, new restrictions in effect include requiring visitors to wear face coverings and maintain a six-foot distance from individuals outside of their party, and prohibiting the gathering of groups larger than five.

TPWD Law Enforcement has assigned personnel to the Caldwell County EOC as a PIO.

TPWD Game Wardens are answering the State Operations Centers call to assist DSHS with state vehicles to expedite delivery of PPE throughout the State of Texas via the state-wide shared spreadsheet.

TPWD continues to have personnel assigned to the SOC to serve as liaison officers between TPWD, TDEM and other Federal, State, and local partners.

Texas Workforce Commission (TWC): TWC has 88.11% of its staff in Texas teleworking.

Volunteer Organizations Active in Disaster (VOADs)

- TDA is working on expediting some existing TEFAP/Trade Mitigation/Bonus Buy orders (i.e., moving orders up from May to April or June to May, etc.).
 - While this may be useful for some food banks, these orders were already in the pipeline to meet EXISTING need in their communities (pre-COVID-19).
 - The expediting of orders does nothing to meet any additional need due to COVID-19, and would mean that the food banks would have less resources in June, once these are depleted.
- Additional TEFAP purchases from the Families First and CARE Acts are not expected to arrive at food banks until July, at the earliest.

 Aside from the possibility of transitioning USDA commodities from school districts (NSLP) to food banks (TEFAP), no additional USDA commodities will come to food banks to help them meet the increased need in April – June.

Salvation Army: The Salvation Army is currently monitoring statewide operations at each Salvation Army local Corps and Shelter, providing guidance through Divisional Social Services for shelter operations. Most locations have increased shelter capacity and have gone to 24/7 operations due to the community need. Current feeding operations are local with grab and go type services, food box/pantry distribution. No statewide feeding plan is operational at this time.

The Salvation Army has entered into an agreement with TDEM and The National Guard providing logistics to distribute PPE to various regions.

PREAMBLE

This Buyout and Transfer of Service Area Agreement ("Buyout and Transfer
Agreement") made this day of, 2020, by and between the
City of Rio Hondo, Cameron County, Texas ("City") and East Rio Hondo Water Supply
Corporation, Cameron County, Texas ("East Rio Hondo"), a non-profit water supply corporation
of the State of Texas, sometimes collectively referred to hereinafter as the "Parties."

I. RECITALS

1. City presently holds a certificate of convenience and necessity ("CCN") to provide potable water and sewer service to customers located in an area adjacent to East Rio Hondo's current CCN boundary consisting of approximately 21.6 acres located southeast of the intersection of Industrial Drive and Robertson Road in Cameron County, Texas ("City Transfer Area") as shown on the map attached hereto as Exhibit "A" and incorporated herein for all purposes, under the rules and regulations of the Public Utility Commission ("hereinafter referred to as "PUC"). East Rio Hondo desires to install water and sewer pipelines within the City Transfer Area and to provide the customers located within the City Transfer Area with potable water and sewer service, and City desires that, after East Rio Hondo has completed the installation of water and sewer pipelines within the City Transfer Area, East Rio Hondo provide potable water and sewer service to the customers in the City Transfer Area.

II. COVENANTS AND CONDITIONS

- 2. City agrees to convey and assign, and does hereby convey and assign, to East Rio Hondo the right to serve customers within said City Transfer Area, and East Rio Hondo agrees to purchase, and does hereby purchase, such rights.
- The consideration for the City Transfer Area is the conveyance of property by Quit Claim Deed of the 0.607 acres out of Block 16 and Block 27 of Rio Hondo Park Townsite as referenced in Volume 6129, Page 197, Official Records, Cameron County, Texas (Exhibit "B"), and the 3.35 acres, being a part of Block 255, San Benito Land and Water Company Subdivision, as referenced as Tract 3 in Volume 1573, Page 32, Official Records, Cameron County, Texas. (Exhibit "C") (collectively referred to as the "Property"). East Rio Hondo shall convey the Property to City ("Final Closing") at such time as the conditions for Final Closing set forth herein are satisfied.
- 4. Prior to Final Closing for the City Transfer Area, City and East Rio Hondo agree to join and support an application to the PUC requesting approval of the transfer of the City Transfer Area from the area of City's Certificate of Convenience and Necessity to the area of East Rio Hondo's Certificate of Convenience and Necessity ("Application"). East Rio Hondo shall have the PUC Application filed, and all administrative costs, surveying fees, experts' fees, and attorney's fees relating thereto ("Fees") shall be paid fully and solely by City.

City Transfer Area Release

5. This Buyout and Transfer Agreement is subject to City obtaining a release of any Security Agreement in favor of USDA-RD and/or the TWDB ("City Transfer Area Release") covering the City Transfer Area. All costs for obtaining such releases shall be paid fully and solely by City prior to Final Closing. Upon delivery of the City Transfer Area Release by USDA-

RD and/or TWDB to City, City will give notice to East Rio Hondo and send East Rio Hondo a copy of said City Transfer Area Release.

Property Release

6. This Buyout and Transfer Agreement is further subject to East Rio Hondo obtaining a release of any Security Agreement in favor of USDA-RD, CoBank, and/or the TWDB ("Property Release") covering the conveyance of the Property to City. All costs for obtaining such releases shall be paid fully and solely by City prior to Final Closing. Upon delivery of the Property Release by USDA-RD, CoBank, and/or TWDB to East Rio Hondo, East Rio Hondo will give notice to City and send City a copy of said Property Release.

Final Closing

- 7. Final Closing with respect to the City Transfer Area shall occur not more than forty-five (45) days after all of the following conditions for Final Closing have been completed:
 - i. The Property is conveyed;
 - PUC has approved the transfer and designated East Rio Hondo as the holder of the CCN for the City Transfer Area by written order delivered to East Rio Hondo and City;
 - iii. City has obtained a written release of any security interest in favor of the United States Department of Agriculture-Rural Development (hereinafter referred to as "USDA-RD") and/or the Texas Water Development Board ("TWDB") and a copy of such release has been delivered to East Rio Hondo; and
 - iv. East Rio Hondo has obtained a written release of any security interest in favor of the USDA-RD, CoBank, and/or the TWDB and a copy of such release has been delivered to City; and;
 - v. Fees have been paid by City to East Rio Hondo.

General Provisions

City Transfer Area

- 8. i. Subject to the requirements for Final Closing set forth herein, and until such time as East Rio Hondo completes all pipeline installations, City hereby agrees to continue to supply potable water and sewer service to the customers located within the City Transfer Area under the terms of the City's Ordinances and as currently provided to City's commercial customers located within the City's jurisdictional limits pursuant to its current commercial rate structure as amended from time to time, This provision shall survive the consummation and Final Closing of this Buyout and Transfer Agreement.
- ii. On the first day of the first billing cycle to occur after thirty-five (35) days have elapsed since both 1) the Final Closing has occurred; and, 2) the City has received notice from East Rio Hondo of its completion of the water and/ or sewer pipeline installations, City shall cease supplying said service to the City Transfer Area and East Rio Hondo shall begin supplying potable water and/ or sewer service to the then-current customers or members possessing service to property within the City Transfer Area. Such potable water and sewer service shall be provided at East Rio Hondo's then-current lawful rates as established by East Rio Hondo and upon payment of the membership fee. No additional meter fee, hook-up fee, or other additional charge or deposit will be charged to such customer or member as a condition for such initial or continued service. This provision shall survive the consummation and Final Closing of this Buyout and Transfer Agreement.
- 9. East Rio Hondo agrees to provide written notice in the change of service provider to any and all customers with the City Transfer Area within thirty (30) days prior to the date of change of service provider to the City Transfer Area.

- 10. Any lines and property interests owned by City which run through the City Transfer Area which are necessary for service of water to customers of City within its remaining certified area shall not become the property of East Rio Hondo but shall remain the property of City.
- 11. This Buyout and Transfer Agreement has been approved by the appropriate bodies of East Rio Hondo and City and evidenced by appropriate minutes of the governing bodies, copies of which are attached hereto as *Exhibits "D" and "E"*, respectively, and are executed by the appropriate officers of same.
- 12. Failure to perform any covenant and agreement herein shall entitle the non-breaching party to enforce the provisions hereof by specific performance or injunctive relief in addition to any remedy in damages that either party may be entitled to.
- 13. It is the intent of East Rio Hondo and City, and they do hereby specifically agree, that this Buyout and Transfer Agreement creates no third-party beneficiary rights or interest in or to the supply of any treated water or facility relating thereto, nor to any existing or potential retail customers of East Rio Hondo or City.
- 14. No amendment, modification, or alteration of the terms hereof shall be binding unless the same be in writing, dated and subsequent to the date hereof and duly executed by the parties hereto.
- 15. No waiver by the parties hereto of any default or breach of any term, condition, or covenant of this Buyout and Transfer Agreement shall be deemed to be a waiver of any other breach of the same or other term, condition, or covenant contained herein.
- 16. Each party represents and warrants that (i) it has carefully reviewed this Buyout and Transfer Agreement, (ii) it has at all times been represented by and consulted with legal counsel concerning this Buyout and Transfer Agreement, (iii) any questions that it has pertaining to this

Buyout and Transfer Agreement have been answered and fully explained to it by its counsel, (iv) its decision to execute this Buyout and Transfer Agreement was not based on any statement or representation, either oral or written, made by any person on behalf of the other party, (v) this Buyout and Transfer Agreement constitutes the entire agreement and understanding of the parties, (vi) neither party has assigned, conveyed, hypothecated or transferred any interest in any cause of action relating to the above-described claim, (vii) each party understands that the other party is relying upon these representations and warranties in entering into this Buyout and Transfer Agreement, and (viii) this Buyout and Transfer Agreement may not be amended, modified, or changed orally.

ORDINANCE NO. 2020-002

AN ORDINANCE NO. 2020-002: AN ORDINANCE FOR THE CITY OF RIO HONDO, TEXAS, GOVERNING THE RIO HONDO COMMUNITY CEMETERY, PROVIDING A COMPREHENSIVE RELATED POLICIES AND PROCEDURES, AND PROHIBITING FURTHER INTERMENTS AS STIPULATED, AND REPEALING ALL OTHER ORDINANCES OR POLICIES WRITTEN OR CUSTOMARY IN CONFLICT HEREWITH.

WHEREAS, the Rio Hondo City Commission deems it necessary implement Ordinance No. 2020-002 in order to implement rules for the Rio Hondo Community Cemetery, seize all interments and related policies and procedures to maintain the Community Cemetery.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RIO HONDO, TEXAS:

RIO HONDO COMMUNITY CEMETERY City of Rio Hondo

SECTION 1. GENERAL RULES GOVERNING RIO HONDO COMMUNITY CEMETERY OPERATION:

The following rules shall apply within the Rio Hondo Community Cemetery.

- The COMMUNITY CEMETERY was donated to the City of Rio Hondo for the interment of human remains subject to the rules established in this ordinance, and any applicable federal or state laws.
- All plots in the COMMUNITY CEMETERY are owned and operated by the City of Rio Hondo and interment rights are conveyed to the purchaser by deed for the purpose of burial only. The rights of the Purchaser are subject to such rules and ordinances as may be enacted or amended, from time to time, by the City Commission of the City of Rio Hondo.
- The rules and regulations herein contained are designed for the protection of the rights of all. The rules adopted have been determined to be reasonably necessary and incidental to achieve the a forestated objectives.
- The City of Rio Hondo will not be responsible for any property loss or damage at the COMMUNITY CEMETERY.

- Any person who destroys, defaces, or commits any act of vandalism on any portion
 of the COMMUNITY CEMETERY shall be guilty of a criminal offense punishable in
 accordance with State law and these rules.
- Hours of Operation are from 8am to 6pm.

SECTION 2. RULES SPECIFICALLY GOVERNING BURIAL PLOTS IN RIO HONDO COMMUNITY CEMETERY

The following rules govern the use of burial plots in the Rio Hondo Community Cemetery:

- No grave shall be opened from the date of passage of this ordinance.
- Only upon the death deeded plot owner, it is the duty of the heirs, devisees, or guardian to file with the cemetery management legally accepted proof of their right to use the plot. Burial on a plot may not be permitted until such proof is presented.

SECTION 3. RULES GOVERNING RIO HONDO COMMUNITY CEMETERY MANAGEMENT

The purchase of a plot in the Rio Hondo Community Cemetery has seized.

- The City of Rio Hondo will be managing authority for the Rio Hondo Community CEMETERY.
- All administrative matters pertaining to the operation of the COMMUNITY CEMETERY shall be under the direction of the City Manager or his delegate.
- The City of Rio Hondo will maintain all appropriate records of purchases, property deeds of the cemetery, maps, and contracts.
- The City of Rio Hondo there are no further account for the deposits and financial records of the cemetery.
- The City of Rio Hondo shall provide for the continuing care, maintenance, operation, and improvements to the COMMUNITY CEMETERY. In general, this shall include: road maintenance, mowing, pruning, landscaping or removal of plant material, policing of the grounds, pest control, leveling of monuments, and such other maintenance as may be necessary to keep the COMMUNITY CEMETERY presentable at all times.

• Cemetery care does not include the purchase, erection, repair, or replacement of monuments, headstones, markers, or any other item on a space.

SECTION 4. COSTS AND FEES

Purchasing of Plot(s) is no longer available at the Community Cemetery.

<u>SECTION 5. ADDITIONAL REQUIREMENTS</u>

INTERMENT

All interments shall not occur at the Community Cemetery from the date of passage of this ordinance unless all proper deeds are presented to the City Administrator. All opening and closing of grave sites will be done by a licensed funeral director.

DISINTERMENT

Disinterment shall be permitted only in accordance with applicable State and Local laws and rules.

The cost of the City's participation in disinterment will be charged to the plot owner or his duly authorized representative. The City shall have no liability for any damage resulting from interment.

Any disinterment shall be done under the direction and supervision of a licensed funeral director.

SECTION 6. PLANTING AND OTHER DECORATIONS AT THE RIO HONDO COMMUNITY CEMETERY

- Grass, flowers, shrubs, trees, or other types of vegetation shall be planted only by
 or at the direction of the City Manager or his delegate in accordance with a
 landscape plan for the entire cemetery. Plantings by individuals are prohibited and
 shall be removed by the City.
- The placing of potted plants, cut flowers, baskets, floral pieces, funeral designs, decorations, and all other objects of a temporary nature is permitted adjacent to the monument only on the following occasions: Flag Day, Mother's Day, Father's Day, Memorial Day, Veteran's Day, All Soul's Day, and Christmas. Cut or artificial flowers must be placed in a vase. No glass containers are allowed, and the digging of holes for the placement of potted plants and baskets is prohibited.
- The City of Rio Hondo may remove all such items twelve (180) or more days after placement.

- Funeral tributes placed at the time of burial will be allowed to remain on a plot for a minimum period of forty-eight (48) hours, after which they may be removed by city employees. Relatives and interested parties must recover any desired memento or tribute prior to that time. Funeral tributes may include floral designs and floral accents.
- The following are prohibited within the COMMUNITY CEMETERY except as constructed by the City of Rio Hondo: fences, curbing, enclosures, edgings, iron works and wire works.
- The City Manager or his delegate shall have the right to remove all flowers, potted
 plants, wreaths, baskets, floral pieces, funeral designs, decorations and all other
 objects of a temporary nature when they become withered, unsightly, a safety
 concern, or an obstruction to maintenance.
- The City Manager or his delegate is empowered to and may enter upon any plot and remove anything that may have been erected or placed thereon contrary to the provisions of this section, and may remove any dead or damaged tree, shrub or vine.

MONUMENTS

No above-surface monuments shall be permitted in the Community Cemetery.

All plans for memorials must be submitted to the cemetery management for approval before installation. The City shall not be liable for any damages resulting from the disallowance of monuments which did not receive prior approval.

Monuments and markers must be set during regular working hours. These hours are 8:00am through 4:00 p.m., Monday through Friday. Installment of any monument shall be done by a certified and bonded installer.

SECTION 7. EFFECTIVE DATE

This ordinance shall become effective on June 9, 2020 and after publication.

SECTION 9. PUBLICATION

The City Secretary of the City of Rio Hondo, Texas is hereby authorized and directed to cause a true and correct copy of the caption of this Ordinance to be published in a newspaper having general circulation in the City of Rio Hondo, Cameron County, Texas.

AN ORDINANCE NO. 2020-003: AN ORDINANCE FOR THE CITY OF RIO HONDO, TEXAS, GOVERNING THE RIO HONDO ARROYO PARK CEMETERY, PROVIDING A COMPREHENSIVE SCHEDULE OF FEES, RELATED POLICIES AND PROCEDURES, FACILITIES & GROUNDS FEES AND OTHER FEES AND POLICIES AS STIPULATED.

WHEREAS, the Rio Hondo City Commission deems it necessary to further enact Ordinance No. 2020-003 in order to implement rules for the Rio Hondo Arroyo Park Cemetery, fees, and related policies and procedures.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RIO HONDO, TEXAS:

RIO HONDO ARROYO PARK CEMETERY City of Rio Hondo

<u>SECTION 1. GENERAL RULES GOVERNING RIO HONDO ARROYO PARK</u> CEMETERY OPERATION:

The following rules shall apply within the Rio Hondo Arroyo Park Cemetery (RIO HONDO CEMETERY).

- The RIO HONDO CEMETERY is set apart for the interment of human remains subject to the rules established in this ordinance, and any applicable federal or state laws.
- All plots in the RIO HONDO CEMETERY are owned and operated by the City of Rio Hondo and interment rights are conveyed to the purchaser by deed for the purpose of burial only. The rights of the Purchaser are subject to such rules and ordinances as may be enacted or amended, from time to time, by the City Commission of the City of Rio Hondo.
- The rules and regulations herein contained are designed for the protection of the rights of all. The rules adopted have been determined to be reasonably necessary and incidental to achieve the a forestated objectives.
- The City of Rio Hondo will not be responsible for any property loss or damage at the RIO HONDO CEMETERY.
- Hours of Operation are from 7 am to 6 pm. The speed limit is five (5) mph on roads inside the RIO HONDO CEMETERY.

 Any person who destroys, defaces or commits any act of vandalism on any portion of the RIO HONDO CEMETERY shall be guilty of a criminal offense punishable in accordance with State law and these rules.

SECTION 2. RULES SPECIFICALLY GOVERNING BURIAL PLOTS IN RIO HONDO ARROYO PARK CEMETERY

The following rules govern the use of burial plots in the Rio Hondo Arroyo Park Cemetery:

- Burial plots are intended for the interment of human remains only; interment of pets or non-human remains is prohibited.
- All plots shall be sold in increments of one plot or more upon completion of an application in the form attached. Plots are sold for no purpose other than for the burial of human remains without regard to race, color, national origin, gender, or religion.
- Plots shall be sold for use by the purchaser and certain family members only and shall not be purchased for resale. Only family members related to the purchaser within the second degree by affinity or within the third degree by consanguinity may be buried in a plot.
- When a plot is conveyed by city authorities to two persons, they take title as tenants in common; however, the remains of one person only may be interred in any plot.
- Any sale of a plot by a purchaser or his/her heirs shall be only to the City of Rio Hondo and shall be only for the total amount paid by the purchaser at the time of his/her purchase from the City of Rio Hondo.
- The deed to a plot conveys only the right of burial therein. The City of Rio Hondo shall at all times remain the owner of the real property and the City or cemetery management shall retain control and supervision of all plots that have been sold. The City of Rio Hondo or cemetery management of the RIO HONDO CEMETERY shall have the right to enter any plot and modify or remove any structure, object, improvement or adornment on such plot which may be placed thereon in violation of these rules, or which may be considered unsightly, dangerous, or injurious to the plot, adjoining plots, or to the general appearance of the cemetery.
- No grave shall be opened on a plot except at the request of the purchaser, purchasers, or their qualified heirs. A request to open a grave to receive the remains of any persons other than the purchaser, purchasers, or their qualified family members as provided in this Ordinance shall be made in writing attested to by the

purchaser, purchasers, or their qualified heirs, or shall be made through a court order.

- Upon the death or judicially declared incompetency of a plot owner, it is the duty of the heirs, devisees, or guardian to file with the cemetery management legally accepted proof of their right to use the plot. Burial on a plot may not be permitted until such proof is presented.
- All plots shall be plainly marked by the cemetery management.

SECTION 3. RULES GOVERNING RIO HONDO ARROYO PARK CEMETERY MANAGEMENT

The purchase of a plot in the Rio Hondo Arroyo Park Cemetery represents the buyer's right to utilize the burial plot for himself/herself, or a designated and qualified family member, but the real property itself remains the property of the City of Rio Hondo, and is subject to the rules and regulations contained herein. The City agrees to provide perpetual care of the plots, as follows:

- The City of Rio Hondo will be the managing authority for the Rio Hondo Arroyo Park Cemetery.
- All administrative matters pertaining to the operation of the RIO HONDO CEMETERY shall be under the direction of the City Manager or his delegate.
- The City of Rio Hondo will maintain all appropriate records of purchases, deeds, maps and contracts.
- The City of Rio Hondo will maintain a separate account for the deposits and financial records of the cemetery.
- The City of Rio Hondo will assign a manager or sexton to oversee the operations of the cemetery.
- The City of Rio Hondo shall provide for the continuing care, maintenance, operation, and improvements to the RIO HONDO CEMETERY. In general, this shall include: road maintenance, mowing, pruning, landscaping or removal of plant material, policing of the grounds, pest control, leveling of monuments, and such other maintenance as may be necessary to keep the RIO HONDO CEMETERY presentable at all times.

 Cemetery care does not include the purchase, erection, repair, or replacement of monuments, headstones, markers, or any other item on a space. • Only the City of Rio Hondo may open or close any gravesite.

SECTION 4. COSTS AND FEES

The following prices, costs, and fees for plots and certain services are adopted:

Burial Plots

Adult: Size 4'X 9' Price per space: \$600.00

Infant/Child: Size: not to exceed 42-inches long and 24-inches wide

Price per space: \$400.00

Purchasing of Plot(s)

Need. (before death occurs) Individuals may pay for the plot(s) by one of two methods, namely: 1) full payment at time of purchase or 2) twenty-five (25%) percent down and the remaining balance in twelve or less equal monthly payments. Any outstanding balance must be paid in full before burial takes place.

At Need. (when death occurs) Plots must be purchased and paid in full before burial occurs.

Opening and Closing

The fee for opening and closing an adult gravesite must be done by a licensed funeral director.

- Notice for opening a grave must be given to the cemetery management at least 12 working hours prior to time of interment.
- Notice for opening a grave for Saturday or Sunday interment shall be provided not later than 12:00 p.m. on the Friday preceding the burial.

SECTION 5. ADDITIONAL REQUIREMENTS

INTERMENT

All interments shall be made at the expense of the plot owner.

While a funeral or interment is being conducted all nearby work of any kind shall cease.

Visitors to the RIO HONDO who are not members of a funeral procession or party are forbidden to intrude upon a funeral party or to loiter around an open grave.

Outer Burial Container

An outer burial container shall be required for each burial. Funeral directors performing the burial shall be responsible for the sale and delivery of the outer burial container. Outer burial containers made of wood shall not be permitted.

Burial Equipment

It shall be the responsibility of the funeral director to provide the cemetery burial equipment to be used during the burial ceremony, such as tents, chairs, lowering devices, etc.

DISINTERMENT

Disinterment shall be permitted only in accordance with applicable State and Local laws and rules.

The cost of the City's participation in disinterment will be charged to the plot owner or his duly authorized representative. The City shall have no liability for any damage resulting from interment.

Any disinterment shall be done under the direction and supervision of a licensed funeral director.

SECTION 6. PLANTING AND OTHER DECORATIONS AT THE RIO HONDO ARROYO PARK CEMETERY

- Grass, flowers, shrubs, trees, or other types of vegetation shall be planted only by or at the direction of the City Manager or his delegate in accordance with a landscape plan for the entire cemetery. Plantings by individuals are prohibited and shall be removed by the City.
- The placing of potted plants, cut flowers, baskets, floral pieces, funeral designs, decorations, and all other objects of a temporary nature is permitted adjacent to the monument only on the following occasions: Flag Day, Mother's Day, Father's Day, Memorial Day, Veteran's Day, All Soul's Day, and Christmas. MONUMENTS

All plans for memorials must be submitted to the cemetery management for approval before installation. The City shall not be liable for any damages resulting from the disallowance of monuments which did not receive prior approval.

An installation fee of \$50.00 shall be charged for any monument or marker to be placed in the RIO HONDO CEMETERY.

Monuments and markers must be set during regular working hours. These hours are 8:00am through 4:00 p.m., Monday through Friday. Installment of any monument shall be done by a certified and bonded installer.

ORDINANCE NUMBER 2020-001

ORDINANCE 2020-001 REPLACING ORDINANCE 177 TRUK ROUTE AND ESTABLISHING A TRUCK ROUTE IN THE CITY OF RIO HONDO; AND PROVIDING FOR ENFORCEMENT; PRESCRIBING PENALITIES FOR THE VIOLATION OF ITS PROVISIONS AND PROVIDING FOR SEVERABILITY.

WHEREAS, THE CITY OF RIO HONDO CURRENTLY HAS AN EXISTING TRUCK ROUTE IN THE CITY;

WHEREAS, TRUCK TRAFFIC ON THE EXISTING TRUCK ROUTE IN THE CITY IS CAUSING PUBLIC HEALTH AND SAFETY CONCERNS IN RELATION TO SCHOOLS, PEDESTRIAN TRAFFIC AND RESIDENTIAL AREAS;

WHEREAS, TRUCK TRAFFIC ON THE EXISTING TRUCK ROUTE IS CAUSING PREMATURE ROAD INFRASTRUCTURE DAMAGE; and

WHEREAS, THE CITY DESIRES TO PROTECT THE LIFE SPAN OF CERTAIN ROADS; DECREASE THE RISK OF DANGER TO PERSONS; AND INCREASE THE SAFETY OF CITIZENS BY DIVERTING TRUCK TRAFFIC TO A DIFFERENT ROUTE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RIO HONDO:

SECTION 1. DEFINITIONS: For the purposes of this Ordinance, the following terms, phrases, words and their derivations shall have the meaning given herein. When not inconsistent with the context, words used in the present tense include the future, words in the plural number include the singular number, and words in the singular number include the plural number_ The word "shall" is always mandatory and not merely directory.

- (1) "City" is the City of Rio Hondo, Texas.
- (2) "Deviating Truck" is a truck which leaves and departs from a truck route while traveling inside the city.

- (3) "Person" is any person, firm, partnership, association, corporation, company or organization of any kind.
- (4) "Truck" is all truck tractors, van trailers, semitrailers, house trailers, and/or any vehicle designed or operated for the transportation of property, whose body weight or whose rated or licensed combined body and load weight exceeds seventeen thousand (17,000) pounds, (eight and one-half tons).
- (5) "Truck Route" is a way over certain street, as designated herein, over and along which trucks coming into and going out of the city must operate.

SECTION 2. APPLICATION OF REGULATIONS: All trucks within the City shall be operated only over and along the truck routes herein established and on the other designated streets over which truck travel is permitted.

- (1) Exceptions. This Ordinance shall not prohibit:
- (a) Operation on street of destination. The operation of trucks upon any street where necessary to the conduct of business at a destination point, provided streets upon which such traffic is permitted are used until reaching the intersection nearest the destination point.
- (b) Emergency vehicle. The operation of emergency vehicles upon any street in the city.
- (c) Public Utilities. The operation, of trucks owned or operated by the city, public utilities, any contractor or material man, while engaged in the repair, maintenance or construction of streets, street improvements, or street utilities within the city.
- (d) Detoured Trucks. The operation of trucks upon any officially established detour in any case where such truck could lawfully be operated upon

the street for which such detour is established.

SECTION 3. DESIGNATED STREETS FOR TRUCK USE. The following streets and no others shall be used for truck traffic and shall constitute the "Truck Route" which is hereby established within the, city:

- (1) State Highway 106, also known as Colorado Avenue, from where it enters the west city limits of Rio Hondo to where it exits the east city limits of Rio Hondo;
- (2) State Highway 1846 also known as South Reynolds Street from the intersection FM 106 to where it exits the city limits and
- (3) On Robertson Street from its intersection with State Highway 106, also known as Colorado, Avenue, to the north to the city limits.

SECTION 4. TRUCK TRAFFIC IN THE CITY.

- (1) Outside Origin.
- (a) One destination point. All trucks entering the city for a destination point in the city shall proceed only over one of the streets designated for truck traffic/use, and shall deviate only at the intersection with the street upon which such traffic is permitted, nearest to, the destination point. A deviating truck shall return to the truck route by the shortest permissible route.
- (b) Multiple inside city? destination points. All trucks entering the city for multiple destination points shall proceed only over one of the streets designated for truck traffic/use, and shall deviate only at the intersection with the street upon which such traffic is permitted, nearest to the first destination point. Upon leaving the first destination point, a deviating truck shall proceed to other destination points by the shortest direction and only upon streets upon which such traffic is permitted as stated in this Ordinance. Upon leaving the last destination point a deviating truck shall return to the truck route by the shortest permissible route.
- (2) Inside Origin.
- (a) Outside destination point. All trucks on a trip originating in the city and travelling in the city for a destination point outside the city shall proceed by the shortest direction and only upon streets over which such traffic is permitted to a truck route as herein established.
- (b) Inside destination points. All trucks on a trip originating in the city and travelling in the city for destination points in the city, shall proceed only over streets upon which such traffic is permitted as stated in this Ordinance.

- (1) City Administrator Maintain Maps. The City Administrator shall keep and maintain accurate maps setting out truck routes and streets upon which truck traffic is permitted; the maps shall be kept on file in the office of the City Secretary and shall be available to the public during hours of City Hall operation.
- (2) Public Safety Officer Maintain Signs. The Public Safety Officer of the City shall cause all truck routes and

those streets upon which truck traffic/use is

prohibited to be clearly sign-posted to give notice that this Ordinance is in effect.

- (a) Failure to Post. No person shall be charged with violating the provisions of this Ordinance by reason of operating a truck upon a street wherein truck travel is prohibited unless appropriate signs are posted on such street.
- (3) Weigh-in. The Public Safety Officer and City

Policemen shall have the authority to require the person driving or in control of any commercial vehicle not proceeding over a truck route or street over which truck traffic is permitted to proceed to any public or private scale available for the purpose of weighing and determining whether this Ordinance has been complied with, and such person's failure or refusal to proceed as required shall constitute a violation of this Ordinance punishable as hereinafter prescribed.

SECTION 6. Penalties.

Any person who shall violate any of the provisions of this Ordinance shall be guilty of a misdemeanor, and upon conviction thereof, shall be fined not to exceed Two Hundred (\$500.00) Dollars.

SECTION 7. Ordinances repealed.

All Ordinances or parts of Ordinances in conflict herewith are hereby repealed, and this Ordinance shall be in full force and effect from and after its passage and publication.

SECTION 8. Severability.

If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect the provisions or application of the Ordinance which can be given effect without the invalid

provision or application and	to this end	the provisions	of this	ordinance	are
declared to be severable.					

Section 9. EFFECTIVE DATE

This Ordinance shall become effective on April 15th, 2020
