The Government Body of the City of Rio Hondo, Texas met in a Regular Meeting on May 11, 2021 at 6:30 pm in the Civic Center at City Hall, with Mayor Gustavo Olivares Presiding, Mayor-ProTem Margaret Perez-Present and Commissioners, Joseph Lopez-Present, Olga Gallegos-Present, Esteban Bocanegra- Absent, and Rick Tello-Present.

PLEDGE OF ALLEGIANCE by Mayor Olivares

INVOCATION: by Commissioner Margaret Perez

Regular Agenda:

- 1. Mayor's and Commissioner's Report --Mr. Lopez stated that brush had not been picked up in over a month. Mayor stated that the city needs to be at 75 percent capacity for the park usage and must follow CDC guideline. Bridgefest is being mentioned by committee.
- 2. Reports Administration—The second does is being proposed for the coming Friday. Grant for sidewalks has been approved. This is a \$1,041,000 grant. In the recent past there has been 2- million dollars for the city. Mayor thanked Mr. Medina.

The Government Body of the City of Rio Hondo, Texas met in a Regular Meeting on May 25, 2021 at 6:30 pm in the Civic Center at City Hall, with Mayor Gustavo Olivares Presiding, Mayor-ProTem Margaret Perez-Present and Commissioners, Joseph Lopez- Absent, Olga Gallegos- Present, Esteban Bocanegra- Present and Rick Tello- Absent.

PLEDGE OF ALLEGIANCE by Mayor Olivares

INVOCATION: by Commissioner Margaret Perez

Regular Agenda:

- 1. Mayor's and Commissioner's Report Mayor requested staff keep cutting the grass and spraying.
- 2. Reports Administration. Mr. Medina explained that staff had monitored possible flooding on Heywood and Huisache Street staff had made some correction to the drains and flooding did not occur.
- 3. Public Comment Period: Please Note- The Public Comment Period is designated for hearing concerns regarding City of Rio Hondo Public Policy or City of Rio Hondo business for both items not on the Agenda and items listed on the agenda. No Public Comments
- 4. Status Report on Mesquite Street reconstruction project. (Raul Garcia, Engineer) Mr. Raul Garcia explained that some of the delays were because of utilities on the roadway. He mentioned that AT&T had moved the cables and AEP was moving a telephone pole.
- 5. Discussion regarding Rio Grande Valley garbage collection rates. (Ben Medina and Murl Kimberling). Mr. Medina explained the different rates charged by Republic Services through out the valley. Three Cities that are not with Republic Services.
- 6. Consideration and Action to authorize the City Attorney to develop a contract to extend the current solid waste, bulky waste, and vegetation collection contract with Republic Services for an additional four years. Mr. Omar Rodriquez with Republic Services explained the Republic Services offer of no increase the first year and possible increase of no more than 4% of the water consumer price index for years 3-4. Commissioner Bocanegra motion to permit the attorney to develop a contract with Republic Services and seconded by Commissioner Perez and the motion passed unanimously.
- 7. Consideration and Action contracting Dave's Air Conditioning LLC for the purchase and installation of two (2) ton air condition units for the Library and City Hall in the sum of \$23,485. Mr. Medina explained that the Library Air Condition will be paid by Cameron County Library System and the City Hall will be paid using budget funds. Commissioner Perez and seconded by Commissioner Gallegos to approve the purchase and the motion passed unanimously.

- 8. Consideration and Action in purchasing one 2020 F-150 Police Responder 4x4 WB XL for the sum of \$35,184. Mr. Medina explained that the Police Truck now available at Boggus Ford will be paid using budget funds Covid 19. Commissioner Perez and seconded by Commissioner Gallegos to approve the purchase and the motion passed unanimously.
- 9. Consideration and Action on contracting A-3 Utility Company to install two lift station pumps at the Robert Garza lift station and the sewer plant lift station in the sum of \$30,000. Mr. Medina explained that this project was to install 2 pumps at lift stations. They will be paid using budget funds. Commissioner Perez and seconded by Commissioner Bocanegra to approve the installation and the motion passed unanimously.

MEMORANDUM OF UNDERSTANDING (MOU)

Between the

HARLINGEN CHAMBER OF COMMERCE

THE CITY OF COMBES, THE CITY OF SANTA ROSA, and THE CITY OF LOS INDIOS

Objective:

The Harlingen Chamber of Commerce, ("The Chamber") in association with, The City of Rio Hondo, The City of Primera, The City of Combes, The City of Santa Rosa, and The City of Los Indios ("Parties") share the common goal of developing businesses through education, promotion, and advocacy.

Principle:

Recognizing this mutual goal, this memorandum seeks to formalize a process of cooperation and understanding between the respective organizations and the "Chamber". A working relationship will allow the respective "parties" to share common objectives and solutions to achieve mutually beneficial outcomes.

Communications & Financial aspects:

- A) All external communications relating to the promotion of activities of the memorandum will be done with mutual consent.
- B) Activities inscribed in the memorandum will be actively promoted by the "Chamber" and the respective Parties
- C) Any financial aspects related to the organization of the various activities and the dividing of expenses will be mutually agreed upon by the "Parties" and "Chamber" on a case-by-case basis.
- D) All Cities will participate as a Chamber Partner with a minimum of bronze level membership.

Validity:

The Memorandum will take effect on the date of signature. It will remain initially for a period of one year. It may be renewed thereafter by mutual consent. However, should either party decide to terminate this memorandum, prior to the completion of one year, the same may be amicably decided by the participating organizations by giving a written notice of 3 months from either side. Their joint decision in this regard will be final.
