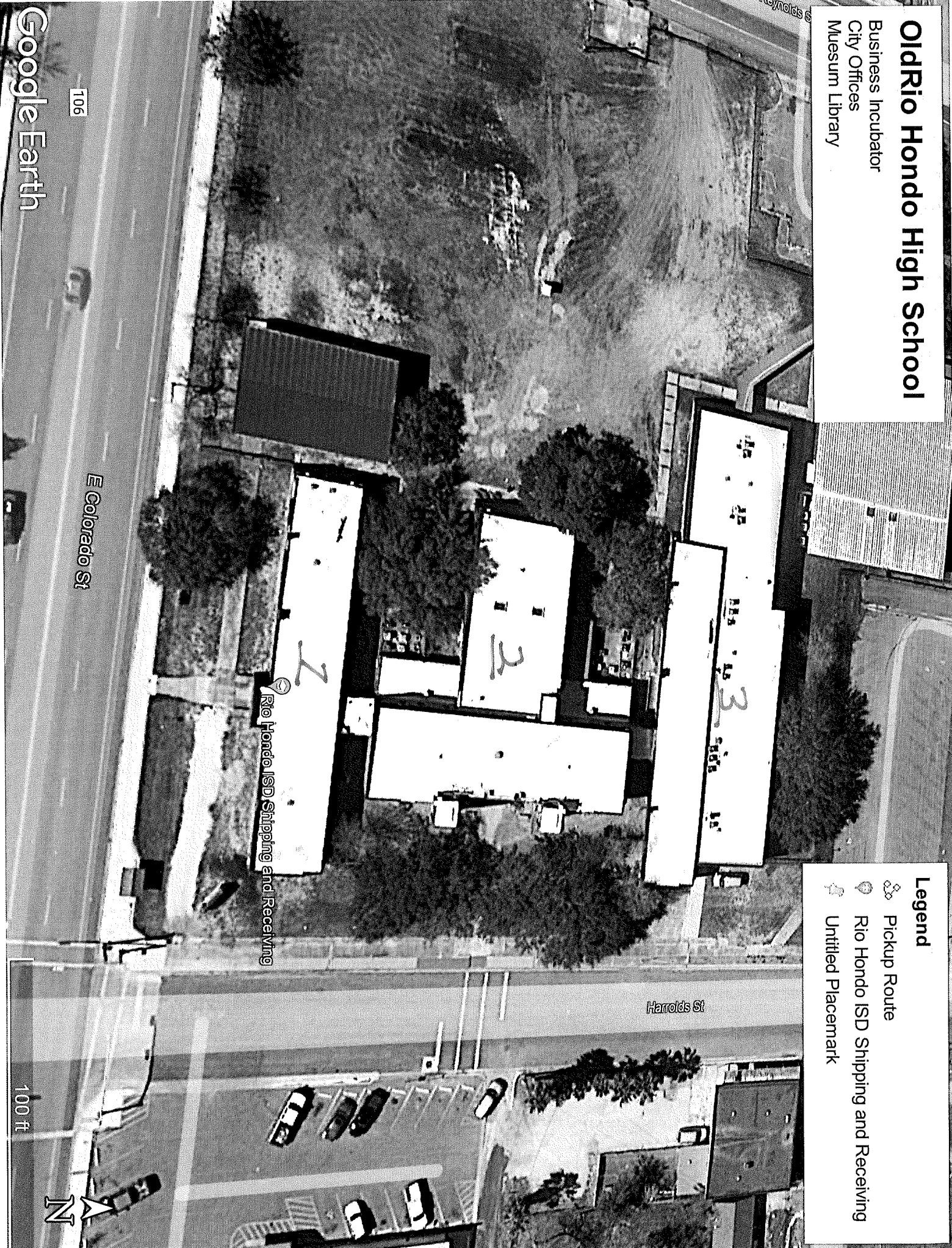

BUYOUT AND TRANSFER OF SERVICE AREA AGREEMENT

STATE OF TEXAS

**§ BETWEEN EAST RIO HONDO WATER
SUPPLY CORPORATION AND CITY OF
RIO HONDO 2020 AREA**

§

PREAMBLE

This Buyout and Transfer of Service Area Agreement (“**Buyout and Transfer Agreement**”) made this ____ day of _____, 2020, by and between the City of Rio Hondo, Cameron County, Texas (“**City**”) and East Rio Hondo Water Supply Corporation, Cameron County, Texas (“**East Rio Hondo**”), a non-profit water supply corporation of the State of Texas, sometimes collectively referred to hereinafter as the “**Parties**. ”

I. RECITALS

1. City presently holds a certificate of convenience and necessity (“**CCN**”) to provide potable water and sewer service to customers located in an area adjacent to East Rio Hondo’s current CCN boundary consisting of approximately 21.6 acres located southeast of the intersection of Industrial Drive and Robertson Road in Cameron County, Texas (“**City Transfer Area**”) as shown on the map attached hereto as *Exhibit “A”* and incorporated herein for all purposes, under the rules and regulations of the Public Utility Commission (“hereinafter referred to as “**PUC**”). East Rio Hondo desires to install water and sewer pipelines within the City Transfer Area and to provide the customers located within the City Transfer Area with potable water and sewer service, and City desires that, after East Rio Hondo has completed the installation of water and sewer pipelines within the City Transfer Area, East Rio Hondo provide potable water and sewer service to the customers in the City Transfer Area.

II. COVENANTS AND CONDITIONS

2. City agrees to convey and assign, and does hereby convey and assign, to East Rio Hondo the right to serve customers within said City Transfer Area, and East Rio Hondo agrees to purchase, and does hereby purchase, such rights.

3. The consideration for the City Transfer Area is the conveyance of property by Quit Claim Deed of the 0.607 acres out of Block 16 and Block 27 of Rio Hondo Park Townsite as referenced in Volume 6129, Page 197, Official Records, Cameron County, Texas (*Exhibit "B"*), and the 3.35 acres, being a part of Block 255, San Benito Land and Water Company Subdivision, as referenced as Tract 3 in Volume 1573, Page 32, Official Records, Cameron County, Texas. (*Exhibit "C"*) (collectively referred to as the "*Property*"). East Rio Hondo shall convey the Property to City ("*Final Closing*") at such time as the conditions for Final Closing set forth herein are satisfied.

4. Prior to Final Closing for the City Transfer Area, City and East Rio Hondo agree to join and support an application to the PUC requesting approval of the transfer of the City Transfer Area from the area of City's Certificate of Convenience and Necessity to the area of East Rio Hondo's Certificate of Convenience and Necessity ("*Application*"). East Rio Hondo shall have the PUC Application filed, and all administrative costs, surveying fees, experts' fees, and attorney's fees relating thereto ("*Fees*") shall be paid fully and solely by City.

City Transfer Area Release

5. This Buyout and Transfer Agreement is subject to City obtaining a release of any Security Agreement in favor of USDA-RD and/or the TWDB ("*City Transfer Area Release*") covering the City Transfer Area. All costs for obtaining such releases shall be paid fully and solely by City prior to Final Closing. Upon delivery of the City Transfer Area Release by USDA-

RD and/or TWDB to City, City will give notice to East Rio Hondo and send East Rio Hondo a copy of said City Transfer Area Release.

Property Release

6. This Buyout and Transfer Agreement is further subject to East Rio Hondo obtaining a release of any Security Agreement in favor of USDA-RD, CoBank, and/or the TWDB (“**Property Release**”) covering the conveyance of the Property to City. All costs for obtaining such releases shall be paid fully and solely by City prior to Final Closing. Upon delivery of the Property Release by USDA-RD, CoBank, and/or TWDB to East Rio Hondo, East Rio Hondo will give notice to City and send City a copy of said Property Release.

Final Closing

7. Final Closing with respect to the City Transfer Area shall occur not more than forty-five (45) days after all of the following conditions for Final Closing have been completed:

- i. The Property is conveyed;
- ii. PUC has approved the transfer and designated East Rio Hondo as the holder of the CCN for the City Transfer Area by written order delivered to East Rio Hondo and City;
- iii. City has obtained a written release of any security interest in favor of the United States Department of Agriculture-Rural Development (hereinafter referred to as “**USDA-RD**”) and/or the Texas Water Development Board (“**TWDB**”) and a copy of such release has been delivered to East Rio Hondo; and
- iv. East Rio Hondo has obtained a written release of any security interest in favor of the USDA-RD, CoBank, and/or the TWDB and a copy of such release has been delivered to City; and;
- v. Fees have been paid by City to East Rio Hondo.

General Provisions

City Transfer Area

8. i. Subject to the requirements for Final Closing set forth herein, and until such time as East Rio Hondo completes all pipeline installations, City hereby agrees to continue to supply potable water and sewer service to the customers located within the City Transfer Area under the terms of the City's Ordinances and as currently provided to City's commercial customers located within the City's jurisdictional limits pursuant to its current commercial rate structure as amended from time to time, This provision shall survive the consummation and Final Closing of this Buyout and Transfer Agreement.

ii. On the first day of the first billing cycle to occur after thirty-five (35) days have elapsed since both 1) the Final Closing has occurred; and, 2) the City has received notice from East Rio Hondo of its completion of the water and/ or sewer pipeline installations, City shall cease supplying said service to the City Transfer Area and East Rio Hondo shall begin supplying potable water and/ or sewer service to the then-current customers or members possessing service to property within the City Transfer Area. Such potable water and sewer service shall be provided at East Rio Hondo's then-current lawful rates as established by East Rio Hondo and upon payment of the membership fee. No additional meter fee, hook-up fee, or other additional charge or deposit will be charged to such customer or member as a condition for such initial or continued service. This provision shall survive the consummation and Final Closing of this Buyout and Transfer Agreement.

9. East Rio Hondo agrees to provide written notice in the change of service provider to any and all customers with the City Transfer Area within thirty (30) days prior to the date of change of service provider to the City Transfer Area.

10. Any lines and property interests owned by City which run through the City Transfer Area which are necessary for service of water to customers of City within its remaining certified area shall not become the property of East Rio Hondo but shall remain the property of City.

11. This Buyout and Transfer Agreement has been approved by the appropriate bodies of East Rio Hondo and City and evidenced by appropriate minutes of the governing bodies, copies of which are attached hereto as ***Exhibits “D” and “E”***, respectively, and are executed by the appropriate officers of same.

12. Failure to perform any covenant and agreement herein shall entitle the non-breaching party to enforce the provisions hereof by specific performance or injunctive relief in addition to any remedy in damages that either party may be entitled to.

13. It is the intent of East Rio Hondo and City, and they do hereby specifically agree, that this Buyout and Transfer Agreement creates no third-party beneficiary rights or interest in or to the supply of any treated water or facility relating thereto, nor to any existing or potential retail customers of East Rio Hondo or City.

14. No amendment, modification, or alteration of the terms hereof shall be binding unless the same be in writing, dated and subsequent to the date hereof and duly executed by the parties hereto.

15. No waiver by the parties hereto of any default or breach of any term, condition, or covenant of this Buyout and Transfer Agreement shall be deemed to be a waiver of any other breach of the same or other term, condition, or covenant contained herein.

16. Each party represents and warrants that (i) it has carefully reviewed this Buyout and Transfer Agreement, (ii) it has at all times been represented by and consulted with legal counsel concerning this Buyout and Transfer Agreement, (iii) any questions that it has pertaining to this

Buyout and Transfer Agreement have been answered and fully explained to it by its counsel, (iv) its decision to execute this Buyout and Transfer Agreement was not based on any statement or representation, either oral or written, made by any person on behalf of the other party, (v) this Buyout and Transfer Agreement constitutes the entire agreement and understanding of the parties, (vi) neither party has assigned, conveyed, hypothecated or transferred any interest in any cause of action relating to the above-described claim, (vii) each party understands that the other party is relying upon these representations and warranties in entering into this Buyout and Transfer Agreement, and (viii) this Buyout and Transfer Agreement may not be amended, modified, or changed orally.

17. The conveyance made in the Buyout and Transfer Agreement is made without warranty, express or implied, and the internal lines and meters, to the extent they exist, are conveyed "AS IS" and "WHERE IS."

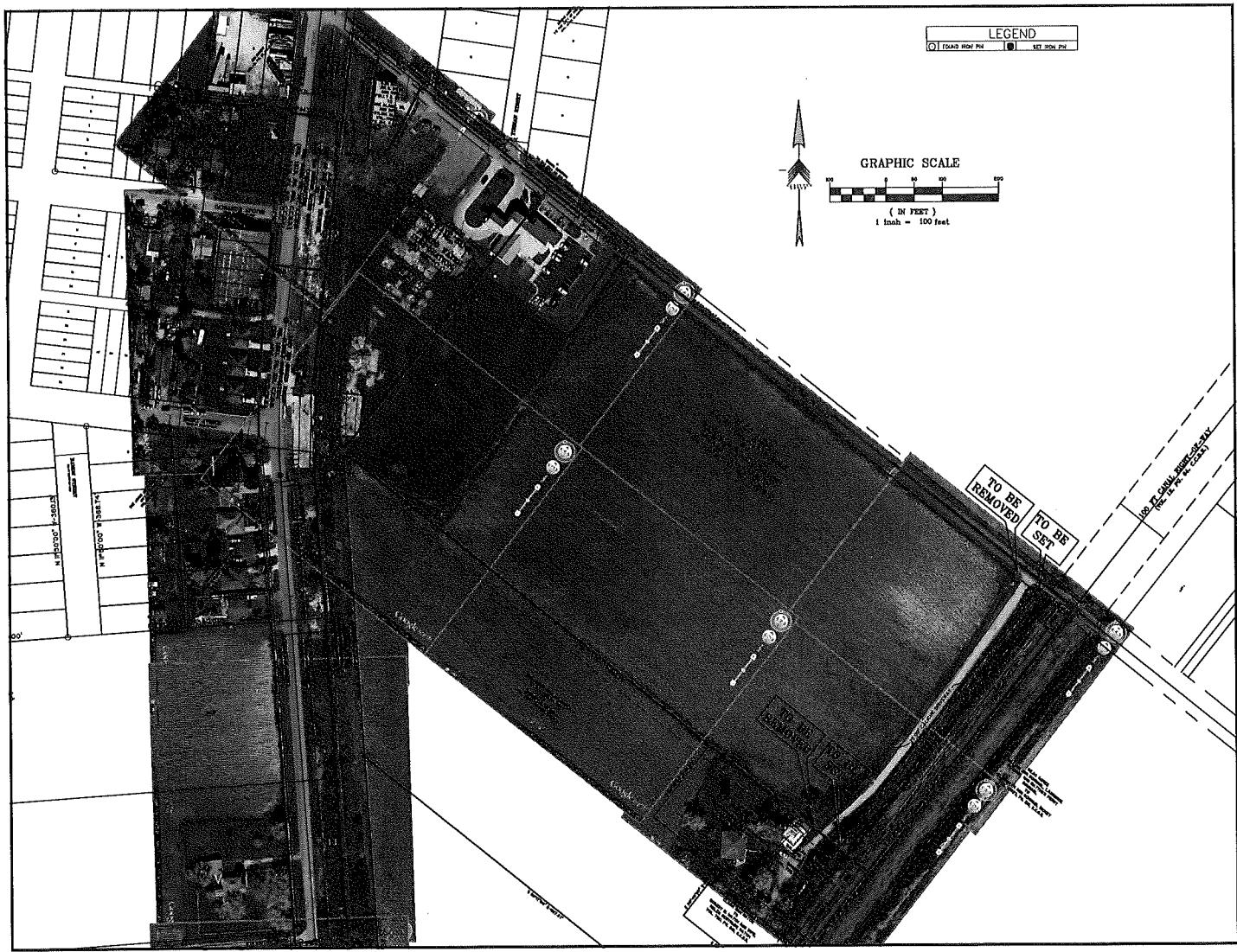

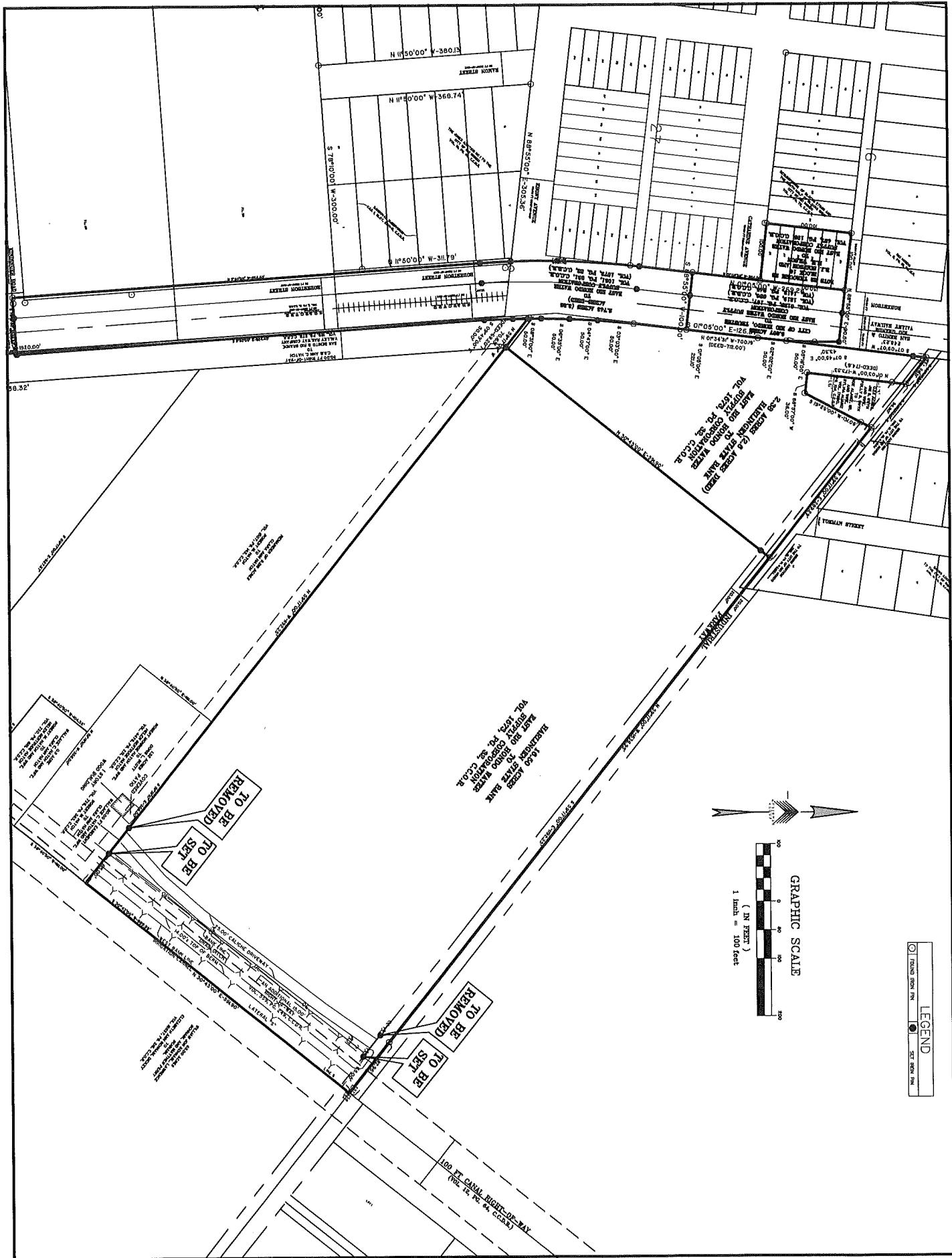

The purpose of this letter is to detail the terms and conditions of utilization of fire hydrants by authorized emergency responders on East Rio Hondo Water Supply Corporation's ("ERHWSC") distribution system. ERHWSC is a non-profit water supply corporation and was created to provide potable water to rural residents in Cameron and Willacy Counties (See attached CCN Map). Unless otherwise provided for in a fire hydrant agreement ("Waterline Access Agreement"), ERHWSC's Tariff states that ERHWSC does not provide water for fire suppression. However, ERHWSC owns several active fire hydrants installed on its distribution system and it is the intent of ERHWSC to provide maximum service to our members and community. ERHWSC fire hydrants are designated as "Fill only" and are painted red with a white "cap" (bonnet) in line with Texas Health and Safety Code §341.03571, and to increase the overall visibility of ERHWSC's active hydrants.

Fill-only fire hydrants are rated for a flow less than 500 gallons per minute and can only be used to fill a water tank on a fire truck used for fire suppression services. Please note that due to varying circumstances (many beyond ERHWSC's control) with its distribution system, ERHWSC does not guarantee the availability and flow rate of water from any of its active fire hydrants. Use of hydrants on the ERHWSC distribution system is on an as-is and where-is basis.

If your department wishes to utilize ERHWSC's active fire hydrants, please note that it must be done in accordance with the terms and conditions established in this letter. Before utilizing ERHWSC's active fire hydrants, please evidence your agreement to the terms and conditions set forth herein by executing and returning a fully-signed and notarized copy of this letter to ERHWSC at the above address. Any utilization of ERHWSC hydrants in a manner other than that addressed in this letter is considered unauthorized use and is not permitted by ERHWSC.

Terms of ERHWSC fire hydrant use:

1. Hydrants may only be used by "Authorized Entities". An Authorized Entity is any municipal, county, or volunteer fire department that has provided an officially authorized signature signifying consent to the terms of this letter.
2. Within 48 hours of utilization of a fire hydrant, the utilizing Authorized Entity must report usage location, peak flow rate utilized, lowest ERHWSC distribution system pressure during utilization, estimated total volumes, and any fire hydrant mechanical malfunctions to ERHWSC Customer Service at (956)-748-3633.
3. An Authorized Entity utilizing ERHWSC fire hydrants is responsible and liable for any damage caused by the Authorized Entity's use of the associated ERHWSC equipment, including but not limited the fire hydrant, and materials.

4. Fire hydrants are to be used solely for actual fire suppression purposes and may not be used for any domestic use, equipment wash-downs, construction purposes, or any other purpose other than the actual use in controlling fires or in maintaining the fire hydrants.
5. ERHWSC distribution system pressure shall not be decreased to a level less than 30 psi during the Authorized Entity's use of ERHWSC's fire hydrant.
6. Entities pursuing utilization of ERHWSC fire hydrants agree to these terms or are not authorized to utilize the fire hydrants. 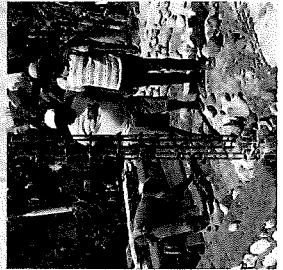
